NOTIFICATION

No. PROC(BBSHRRDB)/1-1/2022-23: Whereas, the firm M/s. Strategic Engineering Solution, Room No. 01, Bungalow No. 19-A, Star Bungalow, Nasim Nagar, Phase-III, Qasimabad, Hyderabad was awarded a contract by BBSHRRDB for the supply of IT equipment as specified in the contract, within the stipulated delivery period, and in accordance with the terms and conditions of the Contract Agreement.

And whereas, as per para 11 of the Contract Agreement dated 11.04.2023, the firm was required to deliver the IT equipment within one month and in case of failure the procuring agency was having right to take any appropriate action against the firm / contractor and to impose penalty. However, despite the lapse of the stipulated timeline, said I. T. equipment have not been delivered to the BBSHRRDB.

And whereas, a notice dated 04.09.2023 was issued to the firm to deliver the IT equipment at the earliest. The firm again failed to comply with the said notice.


And whereas, a final notice dated 10.10.2023 was issued to the firm to deliver the IT equipment within seven (07) days. The firm again failed to comply with the said notice. Consequently, the BBSHRRDB constituted an Inquiry Committee vide Notification No. ADMN / BBSHRRDB / INQUIRY/ 2025/21750 dated 26th May, 2025 to examine the matter. The Committee, in its report dated 02-10-2025, conclusively established that the firm M/s. Strategic Engineering Solution failed to deliver the IT equipment as per the terms and conditions agreed upon with the procuring agency. This constitutes a breach of contract and raises serious concerns regarding procurement integrity. Therefore, the Inquiry Committee recommended that the competent authority should initiate immediate and appropriate action against M/s. Strategic Engineering Solution which may include (i) Recovery of Paid Amount with Financial Penalty and (ii) Blacklisting of the firm M/s. Strategic Engineering Solution from the future Government contracts.

And whereas, notice dated 22.10.2025 was again issued to the firm to deliver the IT equipment within ten (10) days. The firm again failed to comply with the said notice.

And whereas, this continued non-delivery of I.T. equipment constitutes a material breach of contract and an act of gross negligence. Furthermore, the validity period of contract was expired, rendering any further continuation of the contract invalid.

Now, therefore, in exercise of the powers conferred under Rule 35(d) of the Sindh Public Procurement Rules, 2010, BBSHRRDB hereby blacklists M/s. Strategic Engineering Solutions from participating in any future Government contracts for a period of three (03) years.

Additionally, the firm is hereby directed to deposit the paid amount into the relevant Government Treasury Account and submit the deposit receipt to BBSHRRDB without fail.
