



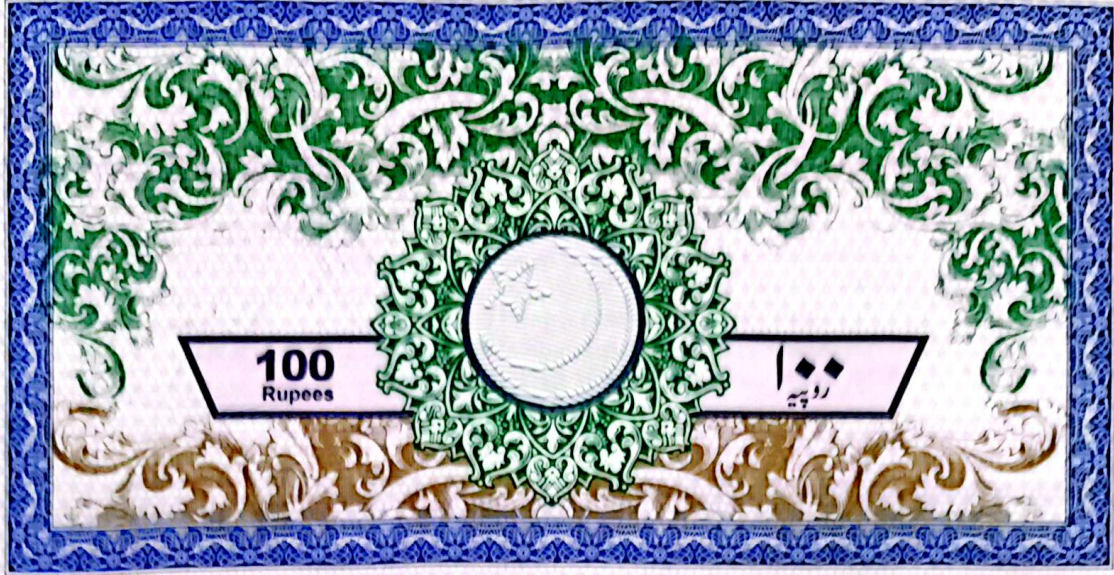

This Memorandum of Understanding (hereinafter referred to as the "MoU") is made at Benazir Bhutto Shaheed Human Resource Research & Development Board (BBSHRADB), Headquarters, 5th Floor State Life Building # 3, Dr. Ziauddin Ahmed Road, Karachi on the day of 16th May, 2025;

BY & BETWEEN:

Overseas Employment Corporation, Ministry of Overseas Pakistanis & Human Resource Development, having its Head Office on 06th Floor, at EOBI Tower, Sector G-10/4, Islamabad, through Mr. Naseer Khan Kashani, Managing Director (hereinafter called as "OEC").

AND

Benazir Bhutto Shaheed Human Resource Research & Development Board (BBSHRADB), having its Headquarters at 5th Floor State Life Building # 3, Dr. Ziauddin Ahmed Road, Opposite, the Chief Minister House Karachi, through Mr. Munawar Ali Mithani, Secretary (hereinafter referred to as "BBSHRADB").

SCOPE OF COLLABORATION

The objective of this MoU is to express the willingness of both parties to engage in bilateral cooperation for sharing data, capacity building, and providing technical assistance to the Graduates of Benazir Bhutto Shaheed Human Resource Research & Development Board (BBSHRADB). **The main focus of the data sharing shall remain the empowerment of Graduates by enabling them to explore foreign job placement opportunities through online platforms.**

The scope of collaboration includes (but is not limited to), the following broad areas:

- Empowerment of Graduates from humble socio-economic backgrounds.
- Foreign job placement of young, talented Graduates as per global demands.
- Access to online foreign job opportunities for young and talented youth so they become successful potential employees and bring a good name to Pakistan.
- Enable Graduates to do foreign job hunting through the OEC Online Job Portal.
- Facilitate Graduates in obtaining foreign language training, which would be helpful for foreign job hunting through OEC.
- Facilitate Graduates in obtaining soft skills training, which would be helpful for foreign job hunting through OEC.
- Any other arrangement as agreed upon by both parties for business needs of both organizations.

Both parties are aware that this MoU is intended only to summarize the current understanding of the parties with respect to the principal terms of the proposed relationship.

ROLES AND RESPONSIBILITIES OF THE PARTIES

Subjected to clause 2 of this MoU, the roles and responsibilities of the parties are as follows:

Responsibilities of BBSHRRDB

BBSHRRDB shall:

- Provide a list of programs and courses (including Course Name, Course Type, Course Discipline, and Course Duration) offered by the contracted Training Institute/ Public Sector Department/University, which will be mapped onto OEC's Online Job Portal.
- Provide details of any new programs/courses to OEC for updating on the OEC Portal.
- Register its trained Graduates and assist in CV-building on OEC's Online Job Portal to facilitate foreign employment.
- Organize awareness campaigns to encourage BBSHRRDB's students to avail the overseas jobs opportunities through OEC's Online Job Portal.
- Facilitate foreign language training (e.g., Korean, Japanese, German, and Arabic) for its students to enhance their employability abroad.
- Provide soft skills training to students to improve their competitiveness in foreign job markets.

Responsibilities of OEC

OEC shall:

- Map the training/course details (Course Name, Course Type, Course Discipline, and Course Duration) in OEC's Online Job Portal.
- Share details of BBSHRRDB and create User/Login credentials for the Institution Dashboard on the OEC's Online Job Portal, enabling BBSHRRDB to review statistics of their registered pass-outs proceeding abroad.
- Ensure foreign job availability for BBSHRRDB -trained graduates based on their skill sets.
- Keep a record of pass-outs who secure foreign employment.
- Take preemptive measures to prevent fraud scams and maintain data privacy before disclosing BBSHRRDB graduates' information to overseas employment promoters (OEPs) and foreign employers.

TERM AND TERMINATION

The MoU shall take effect from the day of 16th May, 2025.

This MoU will remain effective until either party decides to review the terms of cooperation. Either party shall be entitled to withdraw from this MoU upon giving three months' written notice to the other party, delivered to the addresses specified in this document.

At any time before the expiry of the MoU, the parties may renew, amend, or extend the MoU for agreed periods and modifications. However, such an agreement may not be terminated without giving ninety days' prior notice by either party.
